## Observations laid down by Board of Inspection

The deficiencies are :-

1. No qualified Readers/Professors in EC,CP& IT deptt.

2. Dr. P.N. Goswami is Principal, but also shown as Professor in EC deptt.

3. Mr. S. K. Sharma is only M. Tech., but he is shown as Professor.

4. Ms. Archana Nagada is AMIE only, does not qualify for lecturer in Engg. College.

5. Mr. Paras Kothari is MCA only, does not qualify for the post of Associate Professor.

6. The institute has annual subscription of Delnet for session 2009-10 only.

7. Internet bandwidth is insufficient, as per 4 separate branches of 60 intake.

8. Shortage of instruments in laboratories for I year and II year e.g. Physics, Electrical, Electronics etc.

9 Insufficient technical staff in laboratories.

10. There is no conference hall but an auditorium.

11. There is no girl's common room.

12. Mr. Rajendra Singh is sports officer without requisite qualifications.

13. Land area needed is 40460 sgm where as available is 37670 sgm.

Provisional affiliation may be granted as per recommendations of the Board of Inspection (BOI) for the session 2009-10, presuming that deficiencies pointed out above are rectified with in 15 days, from the dispatch of the letter, and compliance report should be sent to the university, failing which the affiliation for session 2010-11 shall not be considered.
