Observations laid down by Board of Inspection

The deficiencies are:-

1. The college plot is around 20 Km, away from the Udaipur city. The college has also hired a floor (about 1500 sq feet area) in a building in the heart of city (Address: 302, Trinity Heights, Above Kotak Mahindra bank, 8-C, Madhuban, Udaipur) and mentions it as city center. The inspection team, after knowing this fact, also visited the city center. This city center is not part of the infrastructure/building map which was approved by AICTE. It was found that there were class room, computer lab, electronics lab etc. in that center. It is a possibility that the city center is used as partially running the regular classes and labs.

2. Dr. Pankaj Porwal is not eligible for the post of Principal due to his teaching experience.

3. Dr. Pankaj Porwal is B.Tech. in Civil Engg., whereas he is shown as Professor in Mech. Engg.

4. At least twenty of the forty three faculty members have joined in the institute to the post of Teaching Associate.

5. Salary given to the faculty is not as per AICTE norms.

6. Some of the faculty members do not seem to be eligible for the post due to insufficient marks in qualifying degree.

7. Some faculty members are pursuing full time M. Tech. and are also shown as full time faculty in the institute. One such case is Mr. Irfan Quazi, who is pursuing M. Tech. from Mewar University. M. Tech. mark sheets and enrollment of all the faculty with PG qualification may be submitted.

8. Some of the faculty members who are shown as Associate Professor do not seem to be fulfilling criteria as per AICTE norms.

9. 3 Faculty members who are shown as Professor in the format do not seem to fulfill the AICTE criteria.

- 10. Recurring expenditure in labs is very low.
- 11. Usage of library is less among the students.
- 12. The fee charged by the institute from the students is varying from students. The variation is very large.
- 13. Library needs improvement.

Status of the current deficiencies shall be verified by the forthcoming inspection team.

Provisional affiliation may be granted as per recommendations of the Board of Inspection (BOI) for the session 2011-12, presuming that deficiencies pointed out above are rectified within fifteen days, from the dispatch of the letter, and compliance report should be sent to the university, failing which the affiliation for session 2012-13 shall not be considered.
