- 1. Principal is not eligible, he has insufficient experience. He has an experience of 7 years after being awarded
- 2. Institute has sent letter to Association of Indian Universities (AIU), New Delhi, on 04.05.2015, for the verification of the qualification of Principal. Reply of AIU is not submitted by the institute.

3. National Journals are not subscribed as per AICTE norms.

During Inspection, students have reported that institute has been charging fees other than prescribed by Technical Education Department, Government of Rajasthan, Jaipur. It is advised not to involve in any illegal direct/indirect Commercialization of Education at your institute, if any.
